MINIMUM WAGE (NATIONAL AND SECTORAL MINIMUM WAGE) ORDER, 2021

The Minister, in exercise of the power conferred on him by section 6(1) of the *Minimum Wage Act*, makes the following Order:

- **1.** This Order may be cited as the *Minimum Wage (National and Sectoral Minimum Wage) Order*, 2021.
- 2. The national minimum wage is set out in the *First Schedule*.
- **3.** The minimum sectoral wage for security guards is set out in the *Second Schedule*.
- **4.** The Wages Councils (Wages Regulation) (Shop Assistants) Order, 2012 (S.I. 2012 No. 14) is revoked.
- 5. This Order shall come into operation on the 1st day of April, 2021.

General Minimum Wage Rates	
1. The minimum rate of wages payable weekly for a 40 hour workweek	340.00 per week
2. The minimum rate of wages payable daily, for an 8 hour workday where an employee is not employed on a weekly basis	68.00 per day
3. The minimum rate of wages payable hourly where an employee is not employed on a weekly or daily basis	8.50 per hour
PART II	
Minimum Overtime Rates	
1. The minimum overtime rate of wages payable for ordinary working days	12.75 per hour or part thereof
2. The minimum overtime rate of wages for Public Holidays	17.00 per hour or part thereof
